INTERGOVERNMENTAL AGREEMENT WITH THE DEPARTMENT OF HAWAIIAN HOME LANDS, FOR LICENSES FOR MAHINAHINA AND **HONOKOWAI (WAI-51)**

Description: The Committee is in receipt of County Communication 19-331, from the Director of Water Supply, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF HAWAII, DEPARTMENT OF HAWAIIAN HOME LANDS FOR FOR (AGREEMENT **LICENSES** MAHINAHINA **AND** HONOKOWAI)." The purpose of the proposed bill is to allow the Department of Water Supply to secure the necessary easements related to the West Maui Water Source Development Project.

- 1. County Communication 19-162, from the Director of Water Supply, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE THE ADOPTING AN UPDATE TO WATER USE DEVELOPMENT PLAN FOR THE ISLAND OF MAUI."
