NOTICE IS HEREBY GIVEN that a public hearing will be held by the Council of the County of Maui, State of Hawaii, on Friday, May 15, 2020, beginning at 9:00 a.m., or soon thereafter, via BlueJeans link <https://primetime.bluejeans.com/a2m/live-event/gcqgczrs> for the purpose of receiving testimony on the following proposed resolution:

ADOPTING THE FUEL TAX RATES FOR THE COUNTY OF MAUI, EFFECTIVE JULY 1, 2020

Pursuant to Section 243-5, Hawaii Revised Statutes, and Section 3.20.010, Maui County Code, the County Council proposes to set the County Fuel Tax rates as follows:

Fuel Tax – Maui, Molokai, Lanai	Tax Rate Per Gallon
Gasoline & Diesel Oil	\$0.240
Biodiesel (B100)	\$0.000
Biodiesel Blend (other than B100)	\$0.060
Ethanol	\$0.115
Methanol	\$0.115
Liquefied Petroleum Gas	\$0.115

"Board Packets", as defined in Section 92-7.5 of the Hawaii Revised Statutes, are available for inspection at the Office of the County Clerk, between 10:00 a.m. and 2:00 p.m., by appointment, on regular business days. "Board Packets" are also available electronically as soon as practicable upon request.

Individuals may provide oral testimony by phone or videoconference. If the connection between any testifier and the videoconference is lost, the public hearing will still continue. Members of the public interested in information about offering testimony at the public hearing may contact the Office of the County Clerk (808 270 7748) prior to the public hearing.

Each testifier shall be allowed to speak for up to three minutes. If approved by the presiding officer and announced prior to any oral testimony being taken, the testifier may be allowed one minute to conclude their testimony. No further oral testimony by the testifier shall be permitted. An individual's request to testify may be deemed withdrawn if the individual does not answer when called to testify.

To ensure its distribution prior to the public hearing, written testimony must be received, e mailed (county.clerk@mauicounty.us), or faxed (808 270 7171) to the Office of the County Clerk at least 24 hours prior to the public hearing.
