#### TRANSIENT ACCOMMODATION MORATORIUM ON **PERMITS** ON LANA'I (PSLU-72)

**Description:** The Committee is in receipt of County Communication 20-423, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE ESTABLISHING CHAPTER 19.97, MAUI COUNTY CODE, DECLARING A MORATORIUM ON TRANSIENT ACCOMMODATION PERMITS ON LANAI." The purpose of the proposed bill is to establish a moratorium on the issuance of transient accommodation permits, for up to one year, until caps for Bed and Breakfast Home permits and Short-Term Rental Home permits are established.

Status: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 20-423 and other related action.
