September 7, 2001, formally adopts the Floodplain Management Plan in accordance with Section 46-11, Hawaii Revised Statutes, and in accordance with the requirements of the National Flood Insurance Program Community Rating System. Section 10 of the Management Plan Floodplain provides that an annual implementation report be presented to the County Council.

  - c. County of Maui Repetitive Loss Properties Floodplain Management Plan Annual Evaluation Report, dated September 2016.

# FIRE APPARATUS ACCESS ROADS FOR ACCESSORY DWELLINGS (PSLU-70)

- **Description:** The Committee is in receipt of County Communication 20-421, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.35, MAUI COUNTY CODE, RELATING TO ACCESSORY DWELLINGS." The purpose of the proposed bill is to correct an inconsistency with the Maui Fire Code regarding fire apparatus access roads to accessory dwellings.

RELATING TO AGRICULTURAL TOURISM USES AND ACTIVITIES IN THE AGRICULTURAL DISTRICT." The purpose of the proposed bill is to establish procedures and requirements for the review and permitting of agricultural tourism uses and activities as an accessory use on a working farm, or farming operation, as defined in Section 165 -2, Hawaii Revised Statutes, implementing Sections 205-2(d)(11), 205 -2(d)(12), and 205-5, Hawaii Revised Statutes.
