### **AUTHORIZING A GRANT OF A LEASE OF COUNTY RECREATIONAL SPACE TO PAIA YOUTH COUNCIL, INC. (HCP-20)**

**Description:** The Committee is in receipt of County Communication 20-559, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "AUTHORIZING A GRANT OF A LEASE OF COUNTY RECREATIONAL SPACE TO PAIA YOUTH COUNCIL, INC." The purpose of the proposed resolution is to authorize the grant of a lease for 3.39 acres of County recreational space, identified for real property tax purposes as tax map keys (2) 2-5-005:017 (por.) and (2) 2-6-001:001 (por.), located at Paia, Maui, Hawaii, at a rental rate of one dollar per year, for the period ending April 30, 2071.
