WATER USE AND DEVELOPMENT PLAN FOR MAUI (APT-57)

Description: The Committee is in receipt of the following:

1. County Communication 19-162, from the Director of Water Supply, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE ADOPTING AN UPDATE TO THE WATER USE AND DEVELOPMENT PLAN FOR THE ISLAND OF MAUI." Attached to the proposed bill is a document entitled "Maui Island Water Use and Development Plan DRAFT, MARCH 2019." The purpose of the proposed bill is to adopt the attached document as an update to the Maui County Water Use and Development Plan, in accordance with Section 14.02.040, Maui County Code.
2. Correspondence dated October 12, 2020, from the County Clerk, transmitting Water, Infrastructure, and Transportation Committee Report 20-128, which was recommitted by the Council at its meeting of October 9, 2020.
3. Correspondence dated August 13, 2020, from the Director of Water Supply, transmitting a draft update to the Water Use and Development Plan for Maui Island and Addendum. The purpose of the revised draft and addendum is to provide necessary updates on relevant developments or decisions that have occurred since the

plan was submitted on August 10, 2018, including revisions discussed at the Water, Infrastructure, and Transportation Committee meetings on July 13, 2020 and August 4, 2020.

4. Correspondence dated May 26, 2021, from the Committee Chair, transmitting the following:
 - a. Streamflow and surface water data listed in Tables 19-3, 19-5, 14-5, and 17-4 of the draft update to the Water Use and Development Plan for Maui and Addendum; and
 - b. Table F-21 of the Hawaii Water Plan, Water Resource Protection Plan, 2019 Update, which provides an inventory of surface water resources and interim instream flow standards throughout Hawaii.

Status: The Committee may discuss the matter and consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 19-162, filing of Committee Report 20-128, filing of the correspondence, and other related action.
