GRANT OF A LEASE EXTENSION TO MAUI NUI BOTANICAL GARDENS (KAHULUI) (HCP-24)

Description: The Committee is in receipt of County Communication 20-614, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "AUTHORIZING A GRANT OF A LEASE OF COUNTY RECREATIONAL SPACE TO MAUI NUI BOTANICAL GARDENS INC." The purpose of the proposed resolution is to authorize an extension to the grant of a lease of County recreational space located at tax map key (2) 3-8-007:001(por.), approximately 6.367 acres, at an annual rental of one-hundred dollars.

Status: The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider the filing of County Communication 20-614 and other related action.
