### MAUI COMMUNITY OUTREACH COURT (HCP-1(2))

### REPEALING THE MINIMUM FINE FOR CERTAIN VIOLATIONS RELATING TO PARKS AND RECREATIONAL FACILITIES (HCP-30)

**Description:** The Committee is in receipt of County Communication 21-78, from Councilmember Gabe Johnson, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE REPEALING THE MINIMUM FINE FOR CERTAIN VIOLATIONS RELATING TO PARKS AND RECREATIONAL FACILITIES." The purpose of the proposed bill is to provide enforcement officers more flexibility in imposing penalties for certain violations relating to parks and recreational facilities.

**Status:** The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee
