AMENDMENTS TO CAPITAL IMPROVEMENT PROJECTS FOR FISCAL YEAR 2022 (DEPARTMENT OF WATER SUPPLY (ACQUISITION OF 1888 WILI PA LOOP BUILDING AND PROPERTY)) (BFED-56(2))

<u>Description:</u> The Committee is in receipt of correspondence, dated September 10, 2021, from the Budget Director, transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI AS PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF WATER SUPPLY, WAILUKU-KAHULUI COMMUNITY PLAN AREA, WATER SUPPLY, BOND FUND, ACQUISITION OF 1888 WILI PA AND LOOP BUILDING PROPERTY; **TOTAL CAPITAL IMPROVEMENTS PROJECT** APPROPRIATIONS: TOTAL APPROPRIATIONS (OPERATING AND CAPITAL **IMPROVEMENT** PROJECTS)." The purpose of the proposed bill is to amend the Fiscal Year 2022 Budget by 1) increasing Bond/Lapsed Bond revenues by \$4,020,000; 2) amending Section 4.I.2.a., Department of Water Supply, Wailuku-Kahului Community Plan Area, Water Supply, by adding "3. Bond Fund" and a project entitled "Acquisition of 1888 Wili Pa Loop Building and Property" in the amount of \$4,020,000; and 3) adjusting the totals accordingly.

- 2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI AS PERTAINS TO APPENDIX C -CAPITAL IMPROVEMENT IT PROJECTS. **DEPARTMENT** OF WATER WAILUKU-KAHULUI COMMUNITY PLAN AREA, ACQUISITION OF 1888 WILI PA LOOP BUILDING AND PROPERTY." The purpose of the proposed bill is to amend the Fiscal Year 2022 Budget, Appendix C, Capital Improvement Projects, by adding a project and project description under the Department of Water Supply, Wailuku-Kahului Community Plan Area, for the Acquisition of 1888 Wili Pa Loop Building and Property in the amount of \$4,020,000.
- 3. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 5219, BILL NO. 48 (2021), RELATING TO THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI ISSUANCE, SALE AND DELIVERY OF SAID BONDS (DEPARTMENT OF WATER SUPPLY ACQUISITION OF 1888 WILL PA LOOP BUILDING AND PROPERTY)." The purpose of the proposed bill is to amend the Fiscal Year 2022 general obligation bond authorization ordinance by adding an appropriation for the Wailuku-Kahului Community Plan Area, Water Supply, for a project entitled "Acquisition of 1888 Will Pa Loop Building and Property," in the amount of \$4,020,000, under the Department of Water Supply.
- 4. A proposed resolution entitled "AUTHORIZING THE ACQUISITION OF APPROXIMATELY 29,712 SQUARE FEET IDENTIFIED AS TAX MAP KEY NO. (2) 3-4-020-049 SITUATED AT WAILUKU, MAUI, HAWAII, FOR AN AMOUNT NOT TO EXCEED \$4,000,000.00." The purpose of the proposed resolution is to authorize the acquisition of approximately 29,712 square feet identified as tax map key (2) 3-4-020-049, situated at Wailuku, Maui, Hawaii, for an amount not to exceed \$4,000,000 plus customary expenses.
- 5. A copy of the appraisal report prepared by R.J. Kirchner, SRA, Paradise Appraisals, LLC, entitled "USPAP COMPLIANT APPRAISAL REPORT OF THE AS IS MARKET VALUE FOR THE FEE SIMPLE INTEREST OF A BANKING BUILDING."

AMENDMENTS TO CAPITAL IMPROVEMENT PROJECTS FOR FISCAL YEAR 2022 (DEPARTMENT OF ENVIRONMENTAL MANAGEMENT (KAHULUI BEACH ROAD SEWER LINE UPGRADE))

(BFED-56(4))

<u>Description:</u> The Committee is in receipt of correspondence dated October 22, 2021, from the Budget Director, transmitting the following:

- 1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES: DEPARTMENT OF MANAGEMENT, ENVIRONMENTAL WAILUKU-KAHULUI COMMUNITY PLAN AREA, SEWER, SEWER FUND, **KAHULUI** BEACH SEWER LINE UPGRADE: **ROAD** TOTAL CAPITAL **IMPROVEMENTS PROJECT APPROPRIATIONS:** TOTAL APPROPRIATIONS (OPERATING AND CAPITAL **IMPROVEMENT** PROJECTS)." The purpose of the proposed bill is to amend the Fiscal Year 2022 Budget by 1) increasing Carryover/Savings revenue from the Sewer Fund in the amount of \$250,000; 2) amending Section 4.A.4.c, Department of Environmental Management, Wailuku-Kahului Community Plan Area, Sewer, Sewer Fund, by adding a project entitled "Kahului Beach Road Sewer Line Upgrade" in the amount of \$250,000; and 3) adjusting the totals accordingly.
- 2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX C - CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, KAHULUI BEACH ROAD SEWER LINE UPGRADE." The purpose of the proposed bill is to amend the Fiscal Year 2022 Budget, Appendix C, Capital Improvement Projects, by adding a project and project description under the Department of Environmental Management, Wailuku-Kahului Community Plan Area, for the Kahului Beach Road Sewer Line Upgrade in the amount of \$250,000.
- 3. A Certification of Additional Revenues for Fiscal Year 2022, dated October 22, 2021, for \$250,000 in Carryover/Savings from the Sewer Fund.

ESTABLISHING CHAPTER 3.17, MAUI COUNTY CODE, RELATING TO THE REDUCTION OF ADMINISTRATIVE FINES (BFED-19)

<u>Description:</u>
The Committee is in receipt of County Communication 20-595, from Councilmember Tamara Paltin, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE ESTABLISHING CHAPTER 3.17, MAUI COUNTY CODE, RELATING TO THE REDUCTION OF ADMINISTRATIVE FINES." The purpose of the proposed bill is to amend Title 3, Maui County Code, by adding a new Chapter 3.17, to codify

policies and procedures for the reduction of administrative fines.
