NOTICE IS HEREBY GIVEN that a public hearing will be held by the Council of the County of Maui, State of Hawaii, on Thursday, November 18, 2021, beginning at 6:00 p.m., or soon thereafter, via BlueJeans link https://maui.bluejeans.com/295235670 for the purpose of receiving testimony on a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.80B.070, MAUI COUNTY CODE, TO ADOPT THE UPDATED WEST MAUI COMMUNITY PLAN."

The purpose of the bill is to adopt the updated West Maui Community Plan, including decennial revisions required by Chapter 2.80B, Maui County Code.

This public hearing is being held in accordance with Section 2.80B.090(D) of the Maui County Code. This public hearing serves as the public hearing for the West Maui Community Plan Area.

Testifiers will be asked to disconnect from the video conference public hearing once their testimony has concluded. Individuals may be disconnected from the public hearing for breaking decorum.

Each testifier shall be allowed to speak for up to three minutes. If approved by the presiding officer and announced prior to any oral testimony being taken, the testifier may be allowed one minute to conclude their testimony. No further oral testimony by the testifier shall be permitted. An individual's request to testify may be deemed withdrawn if the individual does not answer when called to testify.
