<u>Description:</u> The Committee is in receipt of the following:

- Resolution 22-236, entitled "AUTHORIZING SETTLEMENT OF <u>DONALD S. GUZMAN V. COUNTY OF MAUI, ET AL.</u>, CIVIL NO. 21-00202 DKW-RT." Resolution 22-236's purpose is to authorize settlement of the claim filed on April 23, 2021.
- 2. Correspondence dated October 24, 2022, from the County Clerk, with a letter from the Department of the Corporation Counsel, dated October 11, 2022, transmitting a copy of the claim. The claim alleges the Plaintiff's rights to privacy and due process under the United States Constitution were violated in accordance with 42 U.S.C. § 1983 and that the Plaintiff was discriminated against based on a disability in accordance with Hawaii Revised Statutes § 378-2(a)(1)(A).
