We have been blessed that my father Bill Tavares whom some of you may remember as the founder of COMET (Committee For More Equitable Taxation), gave each of his 5 children a piece of Maui so that he and my mom could live out their golden years enjoying their children, grandchildren and great grandchildren living close by. Dad passed away 2 1/2 years ago and would have been 100 years old next month. I know if he were alive, he would be there at the meeting urging each of you for your support of this bill. He was thankful for the "Circuit Breaker" bill the Council passed years ago because it helped many people who used to call him, some crying on the phone begging him and his committee for help.

We have seen property values in Kuau skyrocketing over the years and recently saw a property 2 doors down from mine advertised for \$6 million and then finally sold for \$8 million. I'm pretty sure I would expect my property taxes to increase dramatically in the next year or two. We have put the property into a trust for my children and was considering setting up a special account to help them pay the taxes and other expenses hoping that would help them to hang on to it for their children to enjoy. Hopefully that won't be necessary with your passage of CR 21-95.

Aloha mai, e Vice-Chair Rawlins-Fernandez & County Council Members~ My name is Cody Pueo Pata, and I am the Kumu Hula of Ka Malama Mahilani here on Maui. I am also a Hawaiian culture and language teacher and consultant.

I write to ask that the Council passes: CC 21-484 "SUPPORTING THE HUAMAKAHIKINA DECLARATION AND THE EFFORTS TO PROTECT AND ADVANCE THE PRACTICE OF HULA, AND TO PREVENT ITS CONTINUED ECONOMIC EXPLOITATION AND APPROPRIATION."

200 members of the Huamakahikina Coalition of Kumu Hula have unanimously voted for ratification of the "Huamakahikina Declaration on the Integrity, Stewardship, and Protection of Hula", thus testifying that the Declaration accurately expresses their thoughts and will regarding the integrity, stewardship, and Protection of Hula.

Beginning in late October 2020, the Kumu Hula of the Huamakahikina coalition of Kumu Hula from across Hawai'i and around the world began to work on a formal declaration regarding Hula. We recognized that there was not a single entity—government, social, private, or otherwise—that could speak on behalf of Kumu Hula & Hula better than Kumu Hula, themselves. As such, the processes for the declaration building began.

Between October 2020 to June 2021, the input of around 60 Kumu Hula was reflected in the verbiage of the declaration draft. By late July 2021, the draft was then handed over to a specially-chosen Strategy Support Team, which consisted of 1 Kumu Hula representative, 1 Strategist, and 6 lawyers (with specialties in Hawaiian Law, Intellectual Property, and Policy Making), with the task of refinement and polish.

On August 21-22, 2021, around 160 Kumu Hula from around the world convened at the historic gathering, Kupukalālā Kumu Hula Convention, which was largely funded by the County of Maui, and broadcasted virtually from UHMC. The main purpose of this convention was to modify and ratify what would become the "Huamakahikina Declaration on the Integrity, Stewardship, and Protection of Hula."

To accomplish this, every paragraph was raised in plenary for democratic vote by Huamakahikina Kumu Hula members. The choices were (translated into English): Yes, No, abstain. Although every single paragraph was overwhelmingly passed, registrants who voted "no" or "abstain" were asked to log their reasons into the open chat. These mana'o were then gathered by the hefty team of specially trained staff, and were used in the next steps. After the initial plenary vote took place, all of the Kumu Hula registrants were split into 12-14 breakout sessions led by one specially trained moderator, and equipped with one specially trained note-taker. The Kumu Hula were then given time to debate the mana'o garnered from the plenary session, and submit possible solutions. Reactions and comments were meticulously logged.

Altogether, there were 3 refinement processes which engaged the Kumu Hula registrants. On the last day of the Kupukalālā Kumu Hula Convention, the Declaration was given a final reading, and was unanimously ratified by all Kumu Hula registrants. The ratification process continued for 10 more days as members of the Leo Kāhoa Steering Committee of Huamakahikina contacted elderly Kumu Hula and those who are not tech-saavy for their mana'o.

Ultimately every Kumu Hula involved in the creation of the "Huamakahikina Declaration on the Integrity, Stewardship, and Protection of Hula" <u>unanimously</u> voted for ratification, thus testifying that the Declaration accurately expresses their thoughts and will. As such, I humbly ask that the Maui County Council **Council passes: CC 21-**

484 "supporting the huamakahikina declaration and the efforts to protect and advance the practice of hula, and to prevent its continued economic exploitation and appropriation."
