AUTHORIZING A GRANT OF A LEASE OF COUNTY RECREATIONAL SPACE TO PAIA YOUTH COUNCIL, INC.

WHEREAS, Paia Youth Council, Inc., a Hawaii nonprofit corporation, desires to obtain a lease of recreational space from the County of Maui for a nominal sum; and

WHEREAS, Paia Youth Council, Inc. desires to occupy real property identified as tax map keys (2) 2-5-005:017 (por.), and (2) 2-6-001:001 (por.), an area measuring 1.46 acres ("Premises") and more particularly described and depicted in the Lease Agreement, attached as Exhibit "1"; and

WHEREAS, in accordance with Section 3.36.090, Maui County Code, the Council of the County of Maui may authorize the grant of a lease of County real property by resolution; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That Paia Youth Council, Inc. be granted the right to occupy the Premises in accordance with the terms and conditions of the proposed Lease Agreement, at an annual rental of \$1, to expire January 31, 2072, unless sooner terminated, as provided in Exhibit "1":

- 3. That certified copies of this Resolution be transmitted to the Mayor, the Director of Finance, the Director of Parks and Recreation, and the Executive Director of Paia Youth Council, Inc.
