

APPOINTMENT OF DANIEL KANAHELE TO THE SOUTH MAUI ADVISORY COMMITTEE TO THE MAUI PLANNING COMMISSION FOR THE COUNTY OF MAUI

WHEREAS, under Section 2.28.050, Maui County Code, the South Maui Advisory Committee to the Maui Planning Commission, consists of seven members, where five members are appointed by the Council by resolution, and two members are appointed by the Mayor, and up to two alternates appointed by the Council by resolution; and

WHEREAS, each Advisory Committee member must be a resident of the Kihei-Makena Community Plan Area for a period of at least 12 consecutive months immediately preceding the person's appointment; and

WHEREAS, the terms of Advisory Committee members are five years, except initial terms must be staggered, with four members receiving five-year terms and three members receiving three-year terms, as selected by lot, and except that alternates have three-year terms; and

WHEREAS, the Council appointed four of the five members, and two alternates, at its meeting of December 17, 2021 (Resolution 21-xxx); and

WHEREAS, Section 2.28.070, Maui County Code, requires a member of the South Maui Advisory Committee to have demonstrated expertise in native Hawaiian traditional and customary practices; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Daniel Kanahele to the South Maui Advisory Committee to the Maui Planning Commission for a term to be selected by lot, commencing upon this Resolution's adoption;
2. That it requests that the Planning Director perform the term selection by lot and inform the Council of the resulting term;

3. That the Council expresses its gratitude and appreciation to Daniel Kanahele for his willingness to be considered for public service and actively participate in County government; and
4. That certified copies of this Resolution be transmitted to the Planning Director, Mayor, Managing Director, and the Corporation Counsel.
