

### **PROJECT OVERVIEW**

- Project located on an approximately 3.61-acre site south of Hope Chapel in Kihei at TMK (2)2-2-002:072(por.)
- > 100% Senior Affordable Housing (Rental) Community
- A single three-story building containing 117 apartment units (one (1) and two (2) bedrooms) and related improvements
- All units will be restricted to Seniors earning 60 percent or less of the AMI in accordance with the annual affordable rent guidelines set forth by DHHC

### PROJECT OVERVIEW (continued)

- Managed by Hale Mahaolu
- > Amenities will include:
  - Community gathering space for residents
  - Mailroom
  - Property manager's living unit
  - Office space for onsite staff
  - 143 on-grade parking stalls and two (2) loading stalls

## **RECOMMENDATIONS AND APPROVALS**

#### County of Maui's Urban Design Review Board

Recommended approval of project to MPC at its regular meeting on July 7, 2020

#### Maui County Council

Adopted Resolution No. 20-123 approving the 2.97, MCC application and requested exemptions with modifications on September 11, 2020

#### Maui Planning Commission

Granted the project Special Management Area Use Permit on November 24,2020

#### Maui County Affordable Housing Fund

Award of 4.3 MM AHF Loan Received in January 2020 and extended to FY 2022 in August 2021.









# **2021 HHFDC Funding Round**

- In February of 2021, Liloa Senior Housing, LP submitted a funding application to HHFDC for Low Income Housing Tax Credits (LIHTC, tax-exempt bonds, and Rental Housing Revolving Fund (RHRF)
  - Application was deemed complete by HHFDC and staff provided positive feedback on project, but the project ultimately did not receive an award due to severe funding constraints for bonds
    - Due to no RHRF funding round being held in 2020, the 2021 funding round faced overwhelming demand for bonds from projects that could previously not apply. Bonds were 400% oversubscribed.
    - County demand for bond exceeded normal use, leaving roughly \$150 MM in bonds available to HHFDC, compared to \$306 MM in 2019
    - Over \$70 MM in bonds were awarded to a priority public housing authority project, leaving under \$80 MM for other projects

### Upcoming Requests From Council

- Due to delays in closing, the project will be requesting an extension of its Affordable Housing Fund award to FY 2023
- Because the 2.97 approval expires in September 2022, the project will be seeking a one-year extension in order to provide sufficient time to receive building permit and close. Closing is currently anticipated to take place in Q2 2023, with completion to occur in Q4 2024.
