RELATING TO THE APPOINTMENT OF JOAQUIN FREITAS, JR. TO THE PUBLIC WORKS COMMISSION FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated December 15, 2021, Mayor Michael P. Victorino notified the Council he nominated Joaquin Freitas, Jr. to the Public Works Commission for the County of Maui for a term expiring on March 31, 2024, to fill a vacancy replacing John Blanchard, pursuant to Sections 2.40.220 and Chapter 2.98, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

- 2. That the Council expresses its gratitude and appreciation to Joaquin Freitas, Jr. for his willingness to be considered for public service and actively participate in County government; and
