Dear Mr. Carroll,

Please be assured that it is the intention of the Kahana Sunset AOAO to pursue the Community Plan Agreement ("CPA") and Change in Zoning ("CIZ"). To that end, the Kahana Sunset AOAO Board of Directors has recently approved a resolution authorizing the officers of the Kahana Sunset AOAO to execute any documents necessary to effectuate the CPA and CIZ.

Eurthermore, the Board of Directors will draft a new By-Law for consideration by the Kahana Sunset AOAO ownership. That proposed By-Law will establish ownership recognition of the CPA and CIZ and provide notice of the changes to any future owners. The ownership will vote on the proposed By-Law at our Annual Meeting, scheduled for September 28, 2018. I fully expect that the proposed By-Law will be approved by our ownership.
