BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5217, Bill No. 46 (2021), Draft 1, as amended, "Fiscal Year 2022 Budget", Appendix D – Conditional Language, is hereby amended as it pertains to the Department of Housing and Human Concerns by adding a Condition for a new grant entitled "State of Hawaii – Homeowner Assistance Fund", to read as follows:

 - (1) Disbursement for salaries and premium pay is limited to 22.0 LTA equivalent personnel.

Condition 5(t):

 - (t) Title III Programs
 - (1) Disbursement for salaries and premium pay is limited to 5.0 LTA equivalent personnel.

Condition 5(y):

- 5. Department of Housing and Human Concerns
 - (y) American Rescue Plan Act of 2021 Emergency Rental Assistance Program #2
 - (1) Disbursement for salaries and premium pay is limited to 1.0 LTA equivalent personnel.

Condition 5(z):

- 5. Department of Housing and Human Concerns
 - (z) State of Hawaii Homeowner Assistance Fund
 - (1) Disbursement for salaries and premium pay is limited to 1.0 LTA equivalent personnel."
