Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on January 4, 2022, makes reference to County Communication 21-42, from Council Chair Alice L. Lee, relating to nominations to boards, committees, and commissions.

By correspondence dated November 22, 2021 (received on November 23, 2021), the Acting Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF KAPONO KAMAUNU TO THE MAUI COUNTY CULTURAL RESOURCES COMMISSION," with a completed application for the nominee.

The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Kapono Kamaunu to the Maui County Cultural Resources Commission, for a term expiring on March 31, 2022, to fill a vacancy due to the resignation of Tanya-Lee Greig.

Your Committee notes general appointment procedures for boards, committees, and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code.

Your Committee further notes specific provisions for the Maui County Cultural Resources Commission are located in Sections 2.40.110 and 2.88.030, Maui County Code.

The Council must approve or disapprove the nomination by January 22, 2022, or the nomination will be deemed approved.

- 2. That the Council expresses its gratitude and appreciation to Kapono Kamaunu for his willingness to be considered for public service and actively participate in County government; and
- 3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
