I am writing in support of Maui County settling the Lahaina Injection Well case (HAWAII WILDLIFE FUND, ET AL. V. COUNTY OF MAUI, RELATING TO THE CLEAN WATER ACT).

Both the Hawai'i district court and Ninth Circuit appeals court have already ruled that the County must get a permit under the Clean Water Act to continue discharging treated wastewater into the groundwater via the Lahaina injection wells. I ask the County to withdraw its appeal and work with state and community stakeholders to modernize the treatment facility and invest in water reuse solutions.

Settling the case would end a detrimental challenge against the Clean Water Act and allow the County to avoid further penalties as long as it diligently works toward solutions. The Department of Health has already made clear that private cesspools and septic tanks would not need to get NPDES permits, so there is no risk to individual homeowners.

However, if the County continues its appeal, it threatens to gut the federal Clean Water Act. If the County wins the case at the Supreme Court, polluters across the United States would be free to contaminate water bodies as long as they release their waste from a pipe just short of the waters' edge or into the ground. The Trump Administration and industrial polluters like pipeline companies, the oil and gas industry, manufacturers, coal-burning utilities, and mining associations are all hoping that you will continue the appeal. As elected officials, I hope you will do the right thing, not for the Trump Administration and industrial polluters and present and future generations in Maui and all of Hawai'i.

Maui County has a history of being leaders in environmental protection, and you can uphold this reputation and continue this legacy by withdrawing the appeal. Please help to uphold the Clean Water Act and protect Maui's reefs, which not only provide many economic benefits, but hold cultural and environmental significance for all of Hawai'i. 1. At this committee's hearing on May 20, 2019. Richelle Thompson talked about fines we have to pay if the supreme court rules against COM.

In the underlined parts

She talks about maximum civil penalties, and that the clean water act is a strict liability statute, so you're guilty whether you're aware of the law or not.

Maximum civil penalties are \$53,484 per day, times the 4 lahaina injection wells, for 5 years, which is the Clean Water Act's statute of limitations.

That's \$390K.

She also talks about the 8 Kahului injection wells, which we will be fined for if someone files a complaint. Same math says those fines could be \$780 million

That's a total of \$1 billion, that we will be liable for. How about instead of paying that in fines IF the supreme court rules against COM, this body allocates money over the next decade to actually HELP/fund entities that may be caught up in this COME INTO COMPLIANCE and we just stop allowing the casual polluting of any bodies of water. I'm under the impression that the current settlement ALLOWS COM to use the fine money to upgrade their infrastructure, instead of paying it to the feds. Literally if we operate under the current settlement, EVERYONE wins here, including our future generations and our environment.

She also goes on to say that "Our goal is to operate within the law. IF the supreme court says you need an NPDES permit, the clean water act applies to groundwater discharges, that's what we'll have to do."

I agree. The gentleman from the DOH and Lance Collins both clarified that cesspools are in a different category AND that there are creative permit solutions if needed.

But just for arguments sake, lets say it IS true that if the 9th circuit decision holds up, we have to regulate runoff from car washes, and affordable housing projects....THEN SO BE IT. Ask any of those high school students if carwash runoff and sewage effluent from affordable homes should end up in the ocean and I'll be they'll say no. And they are the ones inheriting this problem.

So, instead of handing this off to a supreme court who is stacked with people who's mission it is to dismantle environmental law in support of corporate profits, lets use the money we stand to lose in fines, and our influence at the state to bring our infrastructure and our state permitting processes in line with both the letter AND the spirit of the Clean Water Act.

2. Amicus briefs filed in support of the Hawaii Wildlife Fund and against the COM from around the US include:

South Carolina dealing with a kinder morgan pipe line rupture into the savannah river Tennessee dealing with private landfill wastewater leach Minnesota, Chippewa dealing with discharge wastewater from mines All of these communities filed briefs concerned that a ruling in the county's favor would gut the clean water act.
