# REMOVAL OF ERIC CUOMO FROM THE COST OF GOVERNMENT COMMISSION FOR THE COUNTY OF MAUI

WHEREAS, by letter dated November 5, 2021, Mayor Michael P. Victorino recommended the removal of member Eric Cuomo from the Cost of Government Commission for the County of Maui due to his non-attendance at any meetings this year; and

WHEREAS, Mr. Cuomo has not attended any board meetings since his appointment in accordance with a letter dated October 28, 2021, from Chair Michael Williams, attached as Exhibit "1"; and

WHEREAS, Mr. Cuomo was appointed to the Cost of Government Commission for the County of Maui by Resolution 21-102, adopted on June 18, 2021, for a term expiring on March 31, 2023; and

WHEREAS, Section 13-2(5) of the Revised Charter of the County of Maui (1983), as amended, provides that "members of boards and commissions appointed by the mayor, with the approval of the council, may be removed for cause upon recommendation of such removal by the mayor and the approval of two-thirds of the entire membership of the council"; now, therefore,

- 1. That it approves the removal of Eric Cuomo from the Cost of Government Commission for the County of Maui;
- 2. That such removal will be effective upon adoption of this Resolution; and
