REMOVAL OF LEINAALA PERRY FROM THE BOARD OF WATER SUPPLY FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated September 22, 2021, Mayor Michael P. Victorino recommended the removal of member Leinaala Perry from the Board of Water Supply for the County of Maui due to her non-attendance at any meetings this year; and

WHEREAS, Mr. Copeland was asked by staff to confirm whether she could continue on the board, and to date, staff has not heard from Ms. Perry, attached as Exhibit "1"; and

WHEREAS, Ms. Perry was appointed to the Board of Water Supply for the County of Maui by Resolution 21-75, adopted on May 7, 2021, for a term expiring on March 31, 2026; and

WHEREAS, Section 13-2(5) of the Revised Charter of the County of Maui (1983), as amended, provides that "members of boards and commissions appointed by the mayor, with the approval of the council, may be removed for cause upon recommendation of such removal by the mayor and the approval of two-thirds of the entire membership of the council"; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it approves the removal of Leinaala Perry from the Board of Water Supply for the County of Maui, effective upon adoption of this Resolution; and
- 2. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, the Director of Water Supply, and the Corporation Counsel.
