Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on January 18, 2022, makes reference to the following:

1. County Communication 21-490, from the Mayor, transmitting a proposed resolution entitled "REMOVAL OF LEINAALA PERRY FROM THE BOARD OF WATER SUPPLY FOR THE COUNTY OF MAUI."

The purpose of the proposed resolution is to approve the removal of Leinaala Perry as a member on the Board of Water Supply due to her non-attendance at board meetings.

2. County Communication 21-532, from the Mayor, transmitting a proposed resolution entitled "REMOVAL OF ERIC CUOMO FROM THE COST OF GOVERNMENT COMMISSION FOR THE COUNTY OF MAUI."

The purpose of the proposed resolution is to approve the removal of Eric Cuomo as a member on the Cost of Government Commission due to his non-attendance at board meetings.

Your Committee notes the Council appointed Ms. Perry as a member to the Board of Water Supply at its meeting of May 7, 2021, for a term expiring on March 31, 2026 (Resolution 21-75, as Amended).

Your Committee further notes the Council appointed Mr. Cuomo as a member to the Cost of Government Commission at its meeting of June 18, 2021, for a term expiring on March 31, 2023 (Resolution 21-102).

In accordance with Section 2.41.090(E), Maui County Code, "in a six-month period, once a board, commission, or committee record reflects a member's non-attendance of fifty percent or more meetings, or absences of at least twenty-five percent of meetings, within thirty days of the member's last excused or unexcused absence, the chairperson of the board, commission, or committee must send a letter to the mayor, with a copy to the council, informing of the member's attendance record."

Further, in accordance with the Revised Charter of the County of Maui (1983), as amended, "members of boards and commissions appointed by the mayor, with the approval by the council, may be removed for cause upon recommendation of such removal by the mayor and the approval of two-thirds of the entire membership of the council."

According to correspondence from the Mayor and a representative of the Board of Water Supply, both dated September 22, 2021, several attempts were made to contact Ms. Perry by phone, email, and certified mail to complete or file the required board paperwork. Ms. Perry did not attend any board meetings since her appointment.

A representative of the Mayor said while it was valuable to have an East Maui representative on the Board of Water Supply, Ms. Perry was involved with other community organizations and was unable to commit her time to serve.

According to correspondence from the Mayor, dated November 8, 2021, and the Chair of the Cost of Government Commission, dated October 28, 2021, Mr. Cuomo did not complete or file the required board paperwork. Mr. Cuomo also did not attend any board meetings since his appointment.

Your Committee found there was cause to remove Ms. Perry from the Board of Water Supply and Mr. Cuomo from the Cost of Government Commission and that they had both been given ample notice of their proposed removal with a meaningful opportunity to be heard.
