Hi Axel,

I hope you are well!

As Favi mentioned, I am the new Community Engagement Officer for Hawaii. Thank you for your patience with us getting back to you. I've included answers to your questions below – please let me know if I can be of further assistance.

Is there any way we may provide immediate relief or reduction of flight paths over Ma`alaea or South Maui?

Immediate relief or reduction of flights over Ma'alaea or South Maui is not something the FAA can provide because changing existing flight procedures is a lengthy and complex process. As new flight procedures are developed by the agency, they must undergo in-depth analysis as required by the FAA's own Safety Management System, a stand-alone process that ensures the safety and integrity of the National Airspace System (NAS). If FAA proposes any changes to existing flight procedures that constitute major federal actions, then FAA must also conduct an environmental review subject to the National Environmental Policy Act (NEPA), which would also take some time.

Are any FAA representatives able to take a meeting with community representatives to discuss this issue and potential solutions?

FAA does not meet with local communities one-on-one because we do not want to give, or appear to give, an unfair advantage to any one party. The FAA has embraced roundtables or other similar forums with broad stakeholder representation as an appropriate venue to engage with stakeholders, including community members, on aviation noise concerns. Roundtables can be temporary or formal bodies designed to build a constituency around a specific need or requirement while pursuing consensus on controversial issues, coordinating with technical groups, and reviewing agency activities.

Please know that we have received other procedure requests related to Kahului Airport and we have advised proponents to work with the affected airport to submit the proposed procedure change to the Instrument Flight Procedure (IFP) Gateway.

How can we ensure that our community's input is considered in the upcoming Hawai`i airspace modernization and optimization effort?

While the potential is being discussed within the FAA, there is not a definitive timeline that has been finalized. As plans progress on the Hawaiian airspace modernization and optimization efforts, there will be opportunities for public involvement.

What opportunities and venues are there for the public to ensure a voice at the table in these plans and future flight paths?

We are not aware of future actions, so we cannot currently provide guidance on what venues will be available. For the time being, we ask that you continue to monitor the Kahului Airport webpage, use the IFP gateway to assist in the notification of proposed actions in your area, and reach out to the airport(s) with your interests and concerns.

Additionally, communities can submit questions or comments regarding noise directly to the FAA by accessing the FAA Noise Portal at <u>https://noise.faa.gov/noise/pages/noise.html</u>.

We look forward to working with Maui on future Hawaii airspace modernization and optimization efforts.
