Your Committee notes general appointment procedures for boards, committees, and commissions are outlined in Section 13-2 of the Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code.

Your Committee further notes the Mayor is required to submit names of nominees to the Council no less than 60 days and no more than 70 days before the prior members' terms expire. If the Council fails to approve or disapprove any of the Mayor's nominees within the time period provided, the nominee will be deemed appointed to fill the vacancy. If the Council disapproves a nominee, the Mayor will be notified immediately.

Accordingly, the Council has until March 28, 2022, to approve or disapprove the Mayor's nominees, or the nominees will be deemed appointed.

By correspondence dated March 2, 2022, the Mayor informed your Committee that Public Works Commission nominee Keshia Leiana Adolpho and Molokai Planning Commission nominee John Robert Sabas withdrew from consideration.

Your Committee interviewed nine nominees for the following boards: Lanai Planning Commission, Liquor Control Commission, Maui Planning Commission, Police Commission, and Public Works Commission.

Your Committee interviewed Lanai Planning Commission nominees Erin Simone Trevino Atacador, Reynold Masaji Gima, and Jay S. Margulies.

Ms. Atacador is the Island Club Manager at Pūlama Lāna'i and serves as an Administrative Assistant for the Lāna'i Chamber of Commerce.

Mr. Gima is retired and volunteers with the Keiki Network and Lāna'i Domestic Violence Task Force. He previously served on the Lanai Community Plan Advisory Committee and the Lanai Planning Commission.

Mr. Margulies is a real estate agent and serves as the President of the Kō'ele Homeowners Association Board of Directors and a board member of the Lāna'i Chamber of Commerce.

Your Committee expressed concern about Ms. Atacador's ability to vote on issues relating to Pūlama Lāna'í, which may require her recusal.

Your Committee also expressed concern about Mr. Margulies' lack of community and cultural knowledge on Lāna'i and Maui County.

Your Committee interviewed Liquor Control Commission nominee William Kaimohala Richardson.

Mr. Richardson is the General Manager of Makena Surf Resort and a member of the Institute of Real Estate Management, Hawai'i Chapter. He previously served in the U.S. Army, and worked for the U.S. Navy Security, U.S. Department of the Interior Indian Affairs, and Honolulu Police Department.

Your Committee questioned his ability to attend meetings and whether his previous employment and experience contribute to his ability to serve on the Liquor Control Commission.

Your Committee interviewed Maui Planning Commission nominees Jerry Edlao (Reappoint) and William Gordon Greig.

Your Committee expressed concern about Mr. Edlao's previous decisions as a Maui Planning Commission member, specifically those that did not reflect the sentiments of public testimony and community feedback.

Your Committee supported Mr. Greig's work ethic, but expressed concern about his ties to the construction industry.

Moving forward, your Committee offered to work with the Mayor to seek a broader range of applications that could help to expand the diversity of backgrounds and expertise of board members on the three Planning Commissions.

Your Committee interviewed Police Commission nominees Lahela Kaleiohawane Aiwohi and Calmentina "Tina" (Pedro) Gomes.

Your Committee expressed concern about the lack of East Maui and West Maui representation on the Commission. Your Committee questioned the nominees' knowledge of police or criminal activity in those areas.

Your Committee also expressed concern about Ms. Gomes' attendance record as a prior County board member.

Your Committee interviewed Public Works Commission nominee Noah Kekaimalu Walin.

Mr. Walin is a Project Coordinator for Pacific Rim Land, Inc. and an Assistant Coach at King Kekaulike High School. He is interested in being involved in decisions that impact the development of Maui. He hopes to work through barriers that restrict the development of affordable housing for Maui residents.

Your Committee questioned a representative from the Office of the Mayor on selected nominees for the following boards: Affirmative Action Advisory Council, Board of Water Supply, Commission on Children and Youth, Fire and Public Safety Commission, Molokai Planning Commission, and Salary Commission.

As the nominee to the Affirmative Action Advisory Council and a resident of Kīhei, Casey Nicole Josiah is a real estate agent at Keller Williams Realty Maui and a Sales Administrative Assistant at Maui Condo and Home LLC.

Ms. Josiah is a Youth Leader at King's Cathedral and Chapels, has helped to organize Miss Maui and Miss America events, and was a Site Aide for the County of Maui Play and Learning Sessions program.

Your Committee inquired about Ms. Josiah's viewpoint on affirmative action and her availability to consistently attend meetings.

Relating to Board of Water Supply nominee Ralph Jude Thomas, the Mayor's representative said Mr. Thomas was nominated because of his work ethic while a County employee and his interest and willingness to learn. If approved, Mr. Thomas could bring Kīhei representation to the board.

Your Committee expressed concern about Mr. Thomas' inexperience on water matters.

Your Committee was satisfied with the qualifications of Commission on Children and Youth nominees Ericka Ashley Chavez, Heidi Angela Drahn, and Brian Thomas McCafferty, but expressed concern on the lack of West Maui representation if all three nominees were approved.

Your Committee expressed additional concern on the increase of criminal activity in West Maui involving youth and supported the need for an individual from West Maui to sit on the board.

In an effort to fill a vacancy on the Commission on Children and Youth with a West Maui representative, Ms. Chavez withdrew from consideration. Your Committee expressed deep appreciation for Ms. Chavez' decision and agreed to work with the Mayor to find a qualified West Maui applicant.

By correspondence dated February 24, 2022, the Mayor informed your Committee that Ms. Chavez withdrew from consideration.

Your Committee acknowledged Fire and Public Safety Commission nominee John LeRoy Buck III's knowledge and commitment to his community, but expressed concern about his leadership capability.

Your Committee expressed concern about the reappointment of Molokai Planning Commission nominee Kaleialoha Moss, specifically about previous comments she made during a Molokai Planning Commission meeting relating to sea-level rise and building in the Special Management Area.

Your Committee noted Salary Commission nominee Uvette Josette Sakamoto is employed by Kōkua Realty, LLC and previously served on the County's Public Works Commission and Grants Review Committee.
