BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5217, Bill No. 46 (2021), Draft 1, as amended, "Fiscal Year 2022 Budget", is hereby amended as it pertains to Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$7,000,000; and by increasing the Total Estimated Revenues in the amount of \$7,000,000, to read as follows:

 - a. Government Facilities
 - (1) Bond Fund
 - (i) 60 [North] South Church S treet Building Renovations[628,000] 7.628,000(ii) 100 Mahalani Street Renovations2,000,000
 - (2) Lapsed Bond Proceeds (i) 60 [North] <u>South</u> Church S treet Building Renovations 1,872,000"

SECTION 3. Fiscal Year 2022 Budget is hereby amended as it pertains to the Total Capital Improvement Project Appropriations to reflect an increase of \$7,000,000, to read as follows:

"TOTAL CAPITAL IMPROVEMENT PROJECT APPROPRIATIONS [176,373,485] <u>183,373,485</u>"

SECTION 4. Fiscal Year 2022 Budget is hereby amended as it pertains to the Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$7,000,000, to read as follows:

"TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS) [874,749,545] <u>881,749,545</u>"

- 2. Section 4.D.1.a., Department of Management, Wailuku-Kahului Community Plan Area, Government Facilities, Bond Fund, by increasing the appropriation for the 60 South Church Street Building Renovations by \$7,000,000;
- 3. Total Capital Improvement Project Appropriations to reflect an increase of \$7,000,000; and
- 4. Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$7,000,000.
