The purpose of the proposed bill is to amend Appendix D by  
amending the conditional language for Countywide Equipment.

The proposed request corrects the placement of one dump truck from the  
Molokai Landfill to the Central Maui Landfill. The equipment was incorrectly  
listed for the wrong district. Furthermore, the request includes changing “one  
wheel loader” to “one loader backhoe” for the Molokai Landfill.
