A BILL FOR AN ORDINANCE AMENDING  
THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI  
AS IT PERTAINS TO APPENDIX D – CONDITIONAL LANGUAGE,  
OPERATING BUDGET – CAPITAL IMPROVEMENT PROJECTS,  
DEPARTMENT OF FINANCE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5217, Bill No. 46 (2021), Draft 1, as amended, “Fiscal Year 2022 Budget”, Appendix D – Conditional Language, is hereby amended as it pertains to Department of Finance, by amending Condition B.1.a(1), to read as follows:

**“APPENDIX D – Conditional Language**

**SECTION 2. OPERATING BUDGET – CAPITAL IMPROVEMENT PROJECTS  
DEPARTMENT OF FINANCE**

Condition B.1.a(1):

a. Other Projects

(1) Bond Fund


(i) Countywide Equipment

- (a) Up to \$2,455,000 must be for one dozer for the Hana Landfill; one mini manual refuse truck for West Maui; one loader backhoe, one roll-off truck, one dump truck, and one Sitework GPS System for the Central Maui Landfill; and [one dump truck, one wheel loader] one loader backhoe and one manual rear loader for the Molokai Landfill.
- (b) Up to \$2,330,000 must be for two 1500-GPM pumper trucks, one each at the Kula Fire Station and Lanai Fire Station.”

SECTION 2. Material to be repealed is bracketed. New material is underscored.

SECTION 3. This Ordinance shall take effect upon its approval.


