

This letter is to notify you that the subject building permit B 2020/0448 has been issued a Stop Work Order under Maui County 16.26B section 114. All work shall immediately cease related to building permit B 2020/0448 no later than 4pm on the 15th of December.

Reason for the Stop Work Order as follows:

- 1. Zoning violation relates to MCC Sec. 19.60.030.A which, at the time the building permit was approved, stated that the building height in the Napili Civic Improvement District "shall not exceed two stories." The term "story" is defined in MCC Sec. 19.04.040. The structure currently exceeds two stories.
- 2. SMA violation relates to HRS Sec. 205A-22, the definition of development, that says "construction or reconstruction of a single-family residence that is less than seven thousand five hundred square feet of floor area...." can be exempt from obtaining a SMA permit. The structure currently exceeds 7,500 sf.
