Re: Special Counsel Disclosures

Dear Council Member Molina;

The proposed employment of special counsel for legal claims against mortgage lenders has extreme potential for conflicts of interests. Needless to say, professional law firms throughout the State of Hawai'i have represented mortgage lenders in the judicial foreclosure of countless local residents' homes.

Corporation Counsel Deputy Brian Bilberry's personal opinion in response to the staff attorney with State of Hawai'i Office of Information Practice ("OIP") investigation, reflects a conclusion which appears to contradict with both the spirit and adopted language of the State of Hawai'i Procurement Code. ¹

"It is Corp Counsel's professional and ethical prerogative to confer with any client verbally and confidentially about any potential conflicts of interest involving retention of special counsel.

When questioned by Council Member Tamara Paltin about attorney disclosures of conflicts of interests, Corporation Counsel Deputy attorney Gary Murai made an ethical statement about professional attorney rules and duties, as follows;

"It is incumbent upon attorneys to disclose potential conflicts of interests."

The Maui County Charter calls for the highest standards of ethical conduct so that the citizens may justifiably have trust and confidence in the integrity of government.² Through this Committee action and special counsel Resolution, may we request the Council establish by rule and policy that the Procurement process include written public disclosures of potential attorney conflicts of interest prior to the employment of special counsel.
