Chair and Members:

Your Climate Action, Resilience, and Environment Committee, having met on May 25, 2022, makes reference to the following:

- 1. Miscellaneous Communication, dated July 26, 2021, from the County Clerk, transmitting Amendment 2 to Contract C6706, between the County of Maui and Fukumoto Engineering, Inc., for Ohukai Road Sidewalk Improvements.
- 2. Miscellaneous Communication, dated November 22, 2021, from the County Clerk, transmitting Contract C7456, between the County of Maui and Bowers + Kubota Consulting, Inc., relating to the South Kihei Road Pavement Rehabilitation.

Your Committee received a presentation and status update from representatives of the Department of Public Works.

Relating to Contract C6706, the Department reported that the design work is effectively completed, but Fukumoto Engineering, Inc. will remain on contract once the work has commenced and throughout the construction period to provide technical oversight. The project scope involves Ohukai Road, from South Kihei Road to Kaiola Place.

Your Committee learned that the sidewalk located along the perimeter of the Hale Kaiola Workforce Housing Project, at the corner of Kaiola and Ohukai Streets, will be constructed by the County pending a Special Management Area Permit.

Relating to Contract C7456, the Department reported that work on the South Kihei Road Pavement Rehabilitation is ongoing, but is

anticipated to be completed in June 2023. Two wastewater force main projects conflict with the projected roadwork, which could delay construction. The project scope involves Lipoa Street to Auhana Road, and Keonekai Road to Kilohana Drive.

Your Committee supported continued efforts of the County to improve roadway and pedestrian infrastructure in South Maui.

Your Committee voted 6-0 to recommend filing of the communications. Committee Chair King, Vice-Chair Sinenci, and members Johnson, Lee, Paltin, and Sugimura voted "aye." Committee member Molina was excused.

Your Climate Action, Resilience, and Environment Committee RECOMMENDS the following:

- 1. That the Miscellaneous Communication relating to Amendment 2 to Contract C6706, between the County of Maui and Fukumoto Engineering, Inc., for Ohukai Road Sidewalk Improvements be FILED; and
- 2. That the Miscellaneous Communication relating to Contract C7456, between the County of Maui and Bowers + Kubota Consulting, Inc., relating to the South Kihei Road Pavement Rehabilitation be FILED.
