SUBJECT: **REVIEW OF CHAPTER 14.06A, RELATING TO WATER
CONSERVATION AND CONTROL OF WATER USAGE DURING
WATER SHORTAGE**

With regards to Chapter 14.06A, Maui County Code (MCC), relating to water conservation and control of water usage during a water shortage, the Department of Water Supply (Department) is transmitting for your review the following information.

Section 14.06A.100, MCC, states the following:

- A. The council shall review the provisions set forth in this chapter beginning January 1, 2017, and every three years thereafter.
- B. As part of the review, the director shall provide a report to the council on all actions taken by the department under this chapter during the review period, including a list of water shortage declarations and, for each water shortage declaration:
 - 1. The areas affected by each water shortage declaration.
 - 2. The duration of each water shortage declaration.
 - 3. The restrictions imposed.

July 18, 2017

Area: Upcountry

Duration: Stage 1 Water Shortage Declaration went into effect on 7/18/17 to 10/25/17. Notification published on 7/24/17, 8/2/17, 8/9/17, 8/16/17, 8/23/17, 9/7/17, 9/14/17, 9/22/17, 9/29/17, 10/5/17, 10/13/17, 10/20/17, 10/25/17.

May 24, 2019

Area: Upcountry

Duration: Stage 1 Water Shortage Declaration went into effect on 5/24/19 to 8/28/19.

September 1, 2020

Areas: Upcountry and West Maui

Duration: Stage 1 Water Shortage Declaration went into effect on 9/8/20 to 11/27/20. Notification published in Maui News on 9/1/20, 9/8/20, 9/15/20, 9/22/20, 9/29/20, 10/9/20, 10/16/20, 10/23/20, 10/30/20, 11/6/20, 11/13/20, 11/20/20, 11/27/20.

Restrictions imposed: Conservation of water; restricted use.

June 25, 2021

Area: Upcountry

Duration: Stage 1 Water Shortage Declaration went into effect on 7/2/21 to 10/22/21. Agricultural customers subject to same restrictions on 9/24/21. Notification published in Maui News on 6/25/21, 7/2/21, 7/9/21, 7/16/21, 7/23/21, 8/6/21, 8/13/21, 8/20/21, 8/27/21, 9/3/21, 9/10/21, 9/17/21, 9/24/21, 10/1/21, 10/8/21, 10/15/21, 10/22/21.
