Description: Amend page 58, Bill 69, CD1, FD1 (2022), Appendix A-II  
Special

Purpose Revenues. This amendment would condition \$950,000 under the Affordable Housing Fund for the Hoku'ula housing development in Hāli'imaile for the installation of underground utilities. The project will convert approximately 1,500 linear feet of power and communication lines from overhead to underground. The project also includes six handhole groups, excavation, lay, and backfill of approximately 7,500 linear feet of 4" conduit with concrete encasement, traffic control needed for shoulder work, and demolition of existing poles.

Motion: Move to amend Appendix A, Part II, Section 3.L, by adding subsection (9) on page 58 to read:

"(9) Up to \$950,000 must be for a grant to Hoku'ula Partners, LLC to install underground utilities for the Hoku'ula residential workforce housing project located at TMK (2) 2-5-003:029."
