Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on May 31, 2022, makes reference to the following:

- 1. County Communication 21-46, from Council Chair Alice L. Lee, relating to litigation matters.
- 2. Resolution 22-52, from the Department of the Corporation Counsel, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 4064548 OF TYRON DELLA."

Resolution 22-52's purpose is to authorize the Department to settle the claim filed on July 6, 2020, under terms set forth in an executive meeting.

By correspondence dated February 18, 2022, the County Clerk transmitted a letter dated February 4, 2022, from the Department of the Corporation Counsel, requesting consideration of Resolution 22-52, a copy of the claim, and documentation relating to the claim.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the claim in regular session. The claim alleges personal injuries and damages to the claimant and the claimant's vehicle as a result of a motor vehicle accident at the intersection of Kaahumanu Avenue and Wahine Pio Avenue, Kahului, Maui, Hawai'i on February 25, 2020, involving a Maui County fleet vehicle operated by a County employee.

The Deputy Corporation Counsel requested an executive meeting to discuss confidential information related to the claim.

Your Committee voted to convene an executive meeting, closed to the public, to consult with legal counsel in accordance with Section 92-5(a)(4), Hawaii Revised Statutes.

Following the executive meeting, your Committee reconvened in regular session.

Based on the information received in executive session and the recommendation of the Department, your Committee voted 8-0 to recommend adoption of Resolution 22-52. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Kama, King, Lee, Paltin, Sinenci, and Sugimura voted "aye." Committee member Johnson was excused.
