WHEREAS, at its June 16, 2022 meeting, the HSAC Executive Committee also approved the nomination of Hawai'i County Councilmember Heather Kimball, pending a NACo Board Presidential Appointment; and

WHEREAS, at its June 16, 2022 meeting, the HSAC Executive Committee nominated Maui County Councilmember Shane Sinenci and Hawai'i County Councilmember Sue Lee Loy to serve as WIR Directors for Fiscal Year 2023; now, therefore,
