BILL NO. ____ (2021)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO NAME THE GLENN H. OTANI BASEBALL FIELD (KULA) AND THE GLENN H. OTANI SCOREBOOTH (WAILUKU)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code, is amended by adding a

new section to be appropriately designated and to read as follows:

"**12.40.280 Glenn H. Otani Baseball Field.** Glenn H. Otani Baseball Field refers to the baseball diamond on the upper New Kula Ballfield at the Kula Park, identified as TMK: (2) 2-2-014:001 and located at 50 Calasa Road, Kula, Hawaii."

SECTION 2. Chapter 12.40, Maui County Code, is amended by adding a

new section to be appropriately designated and to read as follows:

"<u>12.40.290 Glenn H. Otani Scorebooth.</u> Glenn H. Otani Scorebooth refers to the scorebooth at the Ichiro "Iron" Maehara Baseball Stadium, located at 225 Kanaloa Avenue, Wailuku, Hawaii."

SECTION 3. New material is underscored. In printing this bill, the County

Clerk need not include the underscoring.

SECTION 4. This Ordinance takes effect on approval.
