A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO RENAME KULA COMMUNITY CENTER TO VON TEMPSKY COMMUNITY CENTER COMPLEX

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code, is amended by adding a

new section to be appropriately designated and to read as follows:
