A BILL FOR AN ORDINANCE AMENDING  
THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI  
AS IT PERTAINS TO ESTIMATED REVENUES;  
OFFICE OF THE COUNTY COUNCIL,  
WAILUKU-KAHULUI COMMUNITY PLAN AREA,  
GOVERNMENT FACILITIES, BOND FUND,  
OFFICE OF COUNCIL SERVICES OFFICE RENOVATIONS;  
TOTAL CAPITAL IMPROVEMENTS PROJECT APPROPRIATIONS;  
TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), "Fiscal Year 2023 Budget", is hereby amended as it pertains to Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$301,045; and by increasing the Total Estimated Revenues in the amount of \$301,045, to read as follows:

SECTION 3. Fiscal Year 2023 Budget is hereby amended as it pertains to the Total Capital Improvement Project Appropriations to reflect an increase of \$301,045, to read as follows:

"TOTAL CAPITAL IMPROVEMENT PROJECT APPROPRIATIONS [263,785,000] 264,086,045"





2. Section 4, by adding J. Office of the County Council, Wailuku-Kahului Community Plan Area, Government Facilities, Bond Fund, and a project entitled "Office of Council Services Office Renovations" in the amount of \$301,045;
3. Total Capital Improvement Project Appropriations to reflect an increase of \$301,045; and
4. Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$301,045.
