BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:



The total amount appropriated for a project may be used for the work phases provided in the project description. A budget amendment shall be requested if the total amount appropriated will be insufficient to complete all work phases set forth in the project description or if the project description does not clearly represent the work to be performed.


