### SUBJECT: SOUTH MAUI COMMUNITY PLAN UPDATE (PSLU-53)

At its meeting of July 14, 2022, the Council's Planning and Sustainable Land Use ("PSLU") Committee selected you as one of the 18 applicants for further consideration to the South Maui Community Plan Advisory Committee ("CPAC").

The PSLU Committee anticipates finalizing the selection of CPAC members in late August or early September 2022, with dates and times to be determined. Once all 13 members are chosen (nine selected by the Council, four selected by the Mayor), members will be expected to serve for a period of at least six months, which can be extended by the Council. The CPAC will remain in existence until enactment of an ordinance adopting the revisions to the South Maui Community Plan.

We anticipate CPAC meetings to be held in person; however, if COVID-19 restrictions are imposed, the Department of Planning may switch to meeting virtually.

The group I was with came with their own values, opinions, backgrounds, personal and professional experiences, thus us having to come to a group decision seemed a bit daunting at the beginning. I quickly realized that I knew that coming in with an open mind and a willingness to sincerely listen to others would be of great value.

I felt I was able to genuinely contemplate what was being said by the other group members and why what they had said was important to them. Doing so gave me the ability to empathize with them and gave me more of an insight when making my decision that would later become a final group decision.

I felt comfortable asking questions. I asked to "tell me more" so me (and the group as some people were too shy to ask and asked me to ask for them) could better understand. I thanked them for being willing to expound. If I had shared something, I sometimes asked "what do you think?" to get their feedback. I valued their feedback and learned a lot from getting to understand each person's perspective.

The decision that had to be made would dig deep into our core as individual people from a wide cross section of our community whose ultimate decision, as a group, would impact several people's lives forever.

Through continued dialogue that at one time or another seemed to go off on a tangent and later was brought back to focus, we were eventually able to come up with an amicable decision, though not everyone felt it was the utopic outcome, but it was an outcome that was agreeable by both sides. This allowed us to move forward feeling that we did what was expected of us to the best of our ability.

One thing that stood out was as diverse as our group was, everyone in the group was encouraged to speak and everyone was able to respectively disagree if needed and all thoughts were respected throughout the process thus making everyone feel valued and respected. This was a wonderful life experience, and I am glad I had an opportunity to do so.
