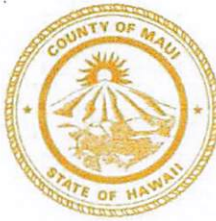

Grant activities will be focused to further the overall Hawaii Strategic Highway Safety Plan strategy of "Improving Data and Safety Management Systems" by collaborating with the Maui Police Department to continue to implement, use, and expand electronic traffic citations in order to a) improve data and safety management systems, and b) improve existing processes to turn data into useful information for law enforcement and other traffic partners. Our agency will attend the International Traffic Records Forum, and attend E-Citation Committee Meetings bi-monthly with other counties on Oahu. Grant also includes a contractual service with Thin Blue Line to allow prosecutors portal access for e-citation data.





19. Addendum

This addendum increases the Contractual/Consultant Services cost from \$450 to \$3,266.02, to fund user licenses for the eCitation pilot program. The grant budget had inadvertently included only enough funding for one user license, even though their proposal had requested funding for seven user licenses. This grant and the FFY 2022 Highway Safety Plan were approved with the seven user licenses.

The new total for this grant project is \$8,491.02.
