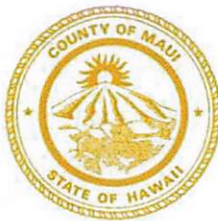

The STOP grant's allocation for prosecution is distributed through a formula plan in which each county prosecution agency receives a base amount, with the balance of the allocation divided based upon county population. Through this formula distribution, law enforcement agencies are able to develop long-term plans for the funds, leverage and coordinate the STOP funds with local resources, and have greater flexibility for use of funds as needs change.
