A BILL FOR AN ORDINANCE AMENDING CHAPTER 5.22, MAUI COUNTY CODE, RELATING TO LIMITING BICYCLING TOUR OPERATIONS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 5.22, Maui County Code, is amended by adding a section to be appropriately designated and to read as follows:

- "5.22.090 Bicycle tours operating in the Makawao-Pukalani-Kula and Paia-Haiku community plan areas. A. No more than six bicycle tours are allowed to operate each day in each of the Makawao-Pukalani-Kula and Paia-Haiku community plan areas.
- B. No more than ten guests per tour are allowed for bicycle tours operating in the Makawao-Pukalani-Kula and Paia-Haiku community plan areas.
- C. Bicycle tours are only allowed between 9:00 a.m. and 1:00 p.m. if operating in either or both of the Makawao-Pukalani-Kula and Paia-Haiku community plan areas.
- D. Each bicycle tour business is limited to one tour per two hours if operating in either or both of the Makawao-Pukalani-Kula and Paia-Haiku community plan areas.
- E. It is unlawful for any business to conduct unguided bicycle tours in the Makawao-Pukalani-Kula and Paia-Haiku community plan areas.
- F. Guides must ride at the front and back of tour groups if operating in either of the Makawao-Pukalani-Kula and Paia-Haiku community plan areas.
- F. Guests of bicycle tours in the Makawao-Pukalani-Kula and Paia-Haiku community plan areas must sign the Bike Pono pledge: "I will BIKE PONO with awareness of my surroundings, attention to my bike speed, and upmost safety for myself and cars to share the roads.""

SECTION 2. Section 5.22.050, Maui County Code, is amended to read as

follows:

"5.22.050 Inspection of permit. Any person or business issued a permit under this chapter must at all times keep the permit

in a prominent place, convenient for inspection, while engaging in bicycle tour activities. <u>All permit numbers must also be prominently displayed on a bicycle tour business's booking website</u>. Any person

failing to comply with the requirement of this section will be fined not less than \$20 nor more than \$100."

SECTION 3. Section 5.22.060, Maui County Code, is amended to read as

follows:

"5.22.060 Unlawful bicycle tour operations—penalty—

forfeiture. Any business or person who engages in bicycle tour activities without first obtaining a permit issued in conformity with this chapter will be ordered to discontinue the bicycle tour business and fined not less than \$200 nor more than \$1,000 per day for each

day the violation persists."

SECTION 4. Material to be repealed is bracketed. New material is

underscored. In printing this bill, the County Clerk need not include the

brackets, the bracketed material, or the underscoring.

SECTION 5. This Ordinance takes effect upon its approval.
