**SUBJECT: BICYCLE-TOUR PUBLIC SAFETY AND RELATED
LITIGATION CONCERNS (GREAT-44)**

By correspondence dated November 15, 2021, and December 30, 2021, the Government Relations, Ethics, and Transparency Committee received comments from the Acting Police Chief and Chief of Police, respectively, relating to a proposed bill establishing limits and restrictions for commercial bicycle-tour businesses to address public safety, traffic, illegal parking, and related litigation concerns on Maui Island. For your reference, copies of both letters are attached.

In the letter dated December 30, 2021, the Chief of Police expressed concerns about staffing shortages and the department's ability to enforce against nonpermitted bicycle-tour businesses that advertise in Makawao-Pā'ia-Ha'ikū and Pukalani-Kula. Given the Department's concerns, may I please request your response to the following:

1. Should Chapter 5.22, Maui County Code, be repealed until a comprehensive enforcement plan can be implemented?
2. If Chapter 5.22 is not repealed and the Department's staffing shortages inhibit their ability to enforce this section of the Code, which department should be responsible for enforcing Chapter 5.22?

May I please request you transmit your response to **no later than January 14, 2022**, and include the relevant Committee item number in the subject line of your response.

Dear Chair Molina:

This is in response to your request for comments regarding the proposed changes to Maui County Code Chapter 5.22 RELATING TO BICYCLE TOUR BUSINESSES (GREAT-44).

It is the opinion of the Maui Police Department that the new changes will drastically improve the safety and welfare of the bicyclists and vehicle operators of Maui County alike by limiting the number of commercial tours, more clearly defining permit requirements, and increasing penalties.

Although permits are not required for State Highways, and 75 percent of the tours are conducted on State Highways, the bill will help to ensure enforcement measures are taken.

The proposed penalties under 5.22.060 [Unlawful bicycle tour operations] will increase it from a simple violation to a misdemeanor which is satisfactory and is warranted for the offense. The proposed bill also places increased responsibilities and requirements on the business owners, which lessens the liability on the County.

In response to your inquiry, if the Department is allowed to enforce against nonpermitted bicycle-tour businesses that advertise in Makawao-Paia-Haiku and Pukalani-Kula. It is the Department's position that this is a civil issue more than a criminal one.

While we empathize with the concerns that businesses and community members have expressed, the Department doesn't know how many nonpermitted tour businesses are currently operating.

If called upon for assistance relating to safety issues, the Maui Police Department will respond to investigate the situation. However, due to current staffing shortages, our resources must focus on the more critical calls for service to violent crimes.
