A BILL FOR AN ORDINANCE AMENDING APPENDIX A

SECTION 1. Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), as amended, "Fiscal Year 2023 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2023, is hereby amended as it pertains to the Economic Development and Cultural Programs Revolving Fund, by adding an appropriation for the lao Valley Road acquisition in the amount of \$1,500,000 to read as follows:

 - (1) Up to \$150,000 must be for the Maui Historical Society for the repairs and renovations at the Bailey House Museum and accessory buildings.
 - (2) Up to \$150,000 must be for the restoration of Ka`ahumanu Church, Wailuku, Maui, Hawaii.
 - (3) Up to \$1,500,000 must be for acquisition of approximately 0.930 acres and all of the buildings and structures located thereon, identified as Tax Map Key No. (2) 3-3-003-006 and approximately 0.498 acres, identified as Tax Map Key No. (2) 3-3-003-008, located on lao Valley Road, Wailuku, Maui, Hawaii."
