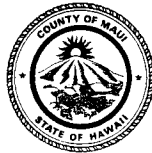

WHEREAS, by correspondence dated March 30, 2022, Mayor Michael P. Victorino notified the Council he nominated the person listed in Exhibit "A," as attached, as a member to the Commission on Children and Youth for the County of Maui, in accordance with Section 2.39.010, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"); and

4. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.




