SUBJECT: AMENDMENTS TO FISCAL YEAR 2023 BUDGET (DEPARTMENT OF FIRE AND PUBLIC SAFETY, FIRE PREVENTION PROGRAM)

On behalf of the Department of Fire and Public Safety, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO THE DEPARTMENT OF FIRE AND PUBLIC SAFETY, FIRE PREVENTION."

MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES – SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2023, FIRE HAZARD REMOVAL REVOLVING FUND."

The purpose of the proposed bill is to amend Appendix A, Part II of the FY 2023 Budget by increasing the Anticipated Revenue for FY 2023 for the Fire Hazard Removal Revolving Fund by \$50,000 and by adding conditional language to allow for expenditure from the fund.

The transfer of the funds from the Fire Prevention Bureau's operations budget to the Fire Hazard Removal Revolving Fund would allow for the operational expenses for fire hazard removal on an ongoing basis.
