On behalf of the Department of Housing and Human Concerns, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES – SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF HOUSING AND HUMAN CONCERNS, (STRATEGIC PREVENTION FRAMEWORK PARTNERSHIPS FOR SUCCESS)."

The purpose of the proposed bill is to amend Appendix A, Part I of the Fiscal Year 2023 Budget by increasing the appropriation for the grant entitled "Strategic Prevention Framework Partnerships for Success" by \$110,000 and by adding 1.0 Limited Term Appointment (LTA) equivalent personnel.
