A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO THE DEPARTMENT OF FIRE AND PUBLIC SAFETY,
FIRE PREVENTION PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), "Fiscal Year 2023 Budget", is hereby amended as it pertains to Section 3.B.6.d, Department of Fire and Public Safety, Fire Prevention Program, by decreasing the appropriation for Category B – Operations & Equipment and Total by \$50,000; and by adding a new appropriation entitled "Transfer to the Fire Hazard Removal Revolving Fund" for \$50,000, to read as follows:
