AUTHORIZING THE COUNTY TO ENTER INTO AN AGREEMENT WITH
THE MAUI VISITORS AND CONVENTION BUREAU REGARDING THE
PLACEMENT AND MAINTENANCE OF REEF SAFE SUNSCREEN
DISPENSERS AT MAUI COUNTY BEACH PARKS AND
OTHER LOCATIONS

WHEREAS, the Maui Visitors and Convention Bureau (“MVCB”) desires to place and maintain Reef Safe Sunscreen Dispensers at Maui County beach parks and other locations; and

WHEREAS, the County of Maui sees the potential benefit of Reef Safe Sunscreen Dispensers being placed at Maui County beach parks and other locations; and

WHEREAS, Chapter 20.42, Maui County Code, “Sunscreen,” takes effect on October 1, 2022; and

WHEREAS, Chapter 20.42 is based on the Council’s finding, stated in Ordinance 5306 (2021), “that, to preserve the health, safety, and welfare of humans and the environment, as well as scenic underwater and natural beauty of Maui County, only mineral sunscreens may be sold, offered for sale, used, or distributed in the County,” subject to certain exceptions; and

WHEREAS, the MVCB has expressed its desire to help ensure the success of what it calls a “historic ordinance” through the placement and maintenance of Reef Safe Sunscreen Dispensers throughout the County by the upcoming effective date; and

WHEREAS, Section 4-1 of the Revised Charter of the County of Maui (1983), as amended, authorizes the Council to act by resolution; and

WHEREAS, this Resolution’s purpose is to express support for the MVCB’s efforts and authorize and urge the Mayor and other County officials to execute any necessary agreements to ensure that the placement and maintenance of Reef Safe Sunscreen Dispensers at Maui County beach parks and other locations occurs promptly; now, therefore,



BE IT RESOLVED by the Council of the County of Maui:

1. That it expresses its appreciation for the Maui Visitors and Convention Bureau's willingness to undertake the placement and maintenance of Reef Safe Sunscreen Dispensers at Maui County beach parks and other locations;
2. That it authorizes the Mayor, or the Mayor's authorized representative, and any relevant department heads to execute any agreements related to the fulfillment of the intent of this Resolution; and
3. That certified copies of this Resolution be transmitted to the Mayor, Managing Director, Environmental Coordinator, Economic Development Director, Director of Environmental Management, Director of Finance, Fire Chief, Director of Parks and Recreation, Planning Director, Chief of Police, Director of Public Works, and the Maui Visitors and Convention Bureau.
